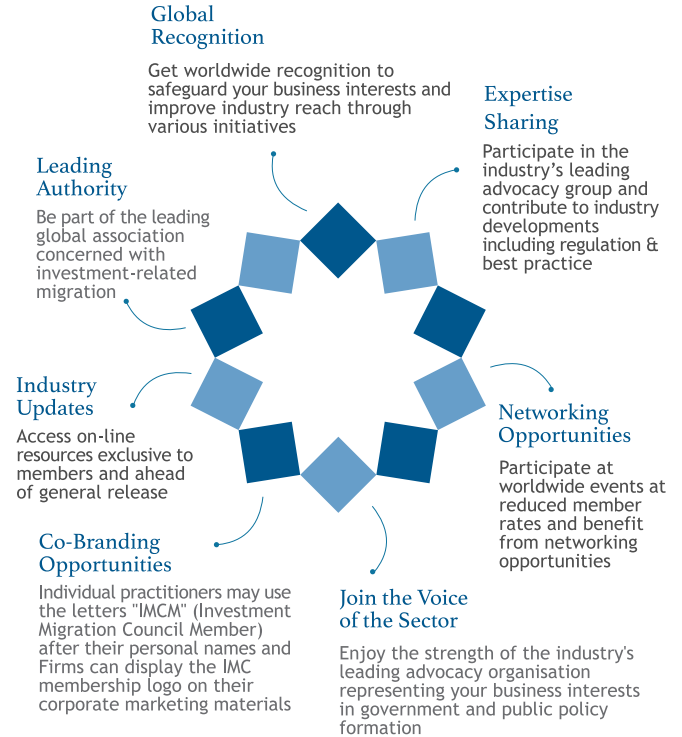
# Membership
