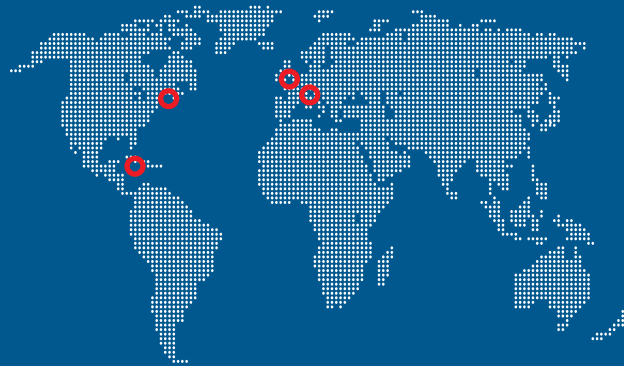

What we do

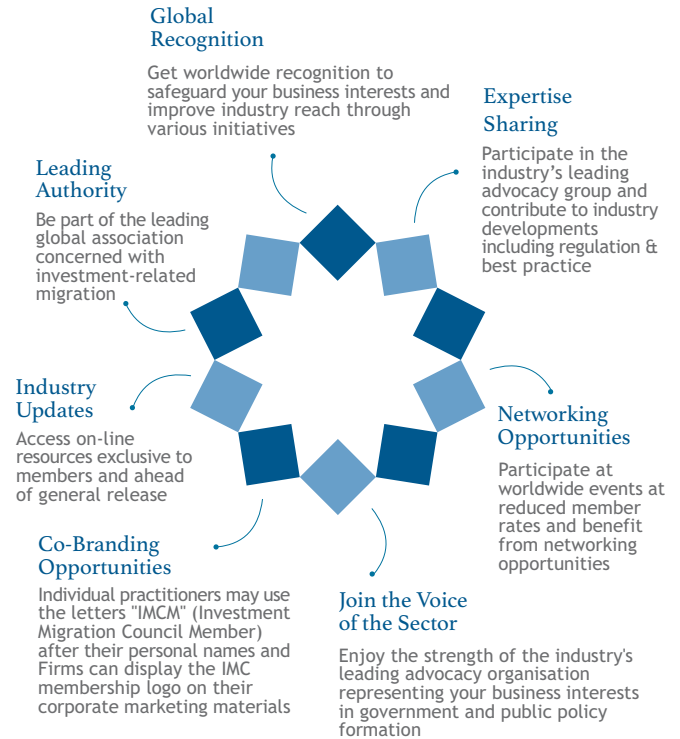
