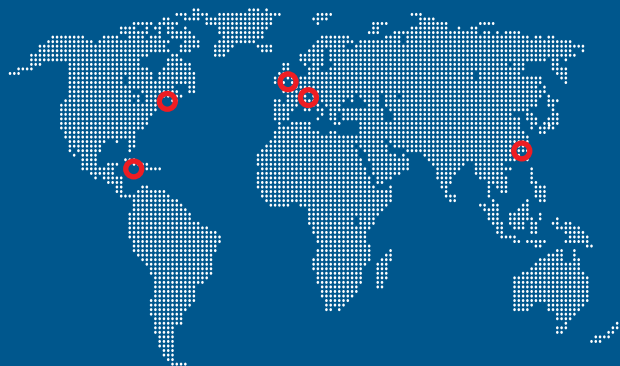

# What we do

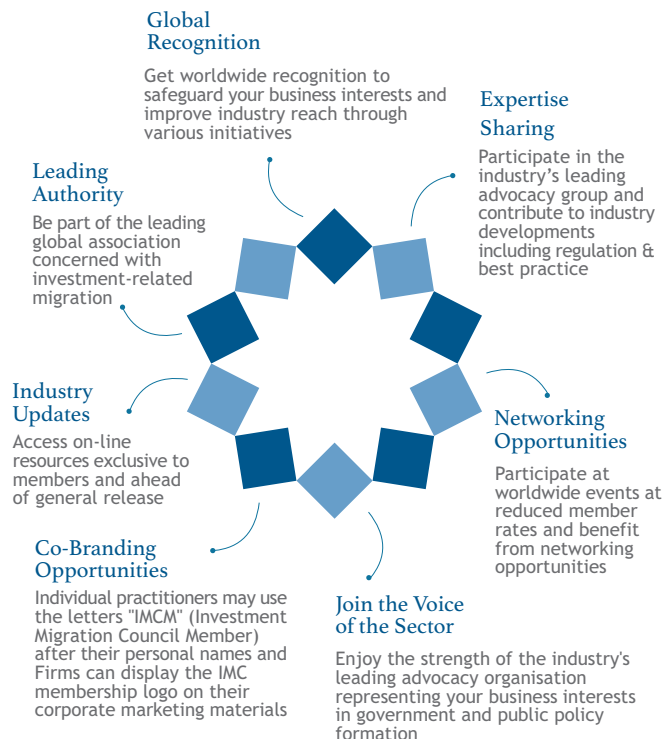
