What we do

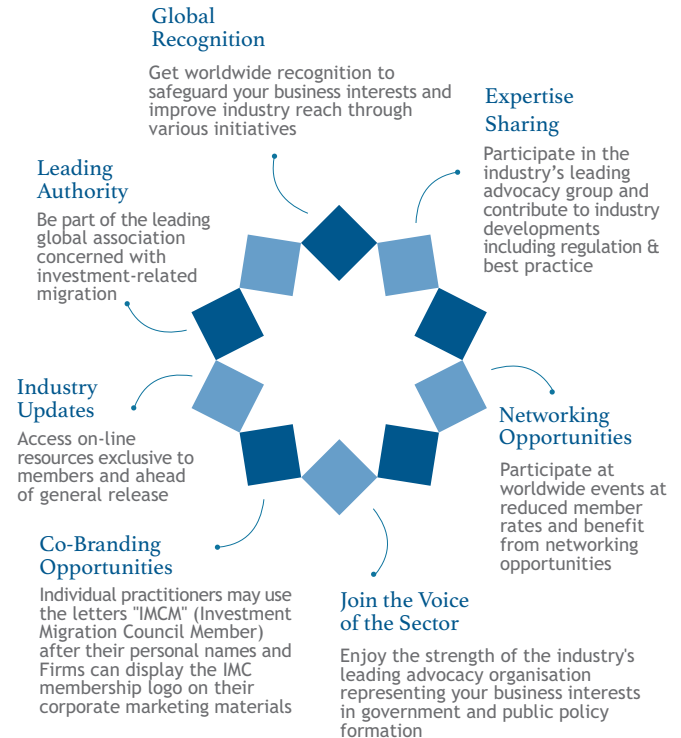
