Bookmark

40 (w) x 180 (h) mm Add 5mm bleed all round to a total size of 50 x 190mm. The bookmark will be printed on both sides



Wrapper

Total size: 430 (w) x 100 (h) mm Visible front part: 210 (w) x 100 (h) mm left and right flaps will be folded to meet at the back with a 10mm overlap for gluing. Add 5mm bleed all round to a total size of 440 x 110mm.
