IMC Field Offices (IMC FOs)

The Investment Migration Council (IMC) is pleased to announce a new initiative in its long-term strategy to expand its global operations and connectivity with the investment migration community.

In the coming months, the IMC will be replacing its Representative Regional Offices (RROs) with IMC Field Offices (IMC FOs) in various locations where investment migration has a healthy potential for growth and expansion. Initially, field offices will be set up in Antigua & Barbuda, St. Lucia, Grenada, St. Kitts & Nevis, Cayman Islands, United Kingdom, USA, Spain, China Portugal, Dubai, Hong Kong, and Panama. Applications for other locations are also welcomed.

Therefore, an open call to IMC members is now open for members who demonstrate the willingness to participate in this new project.

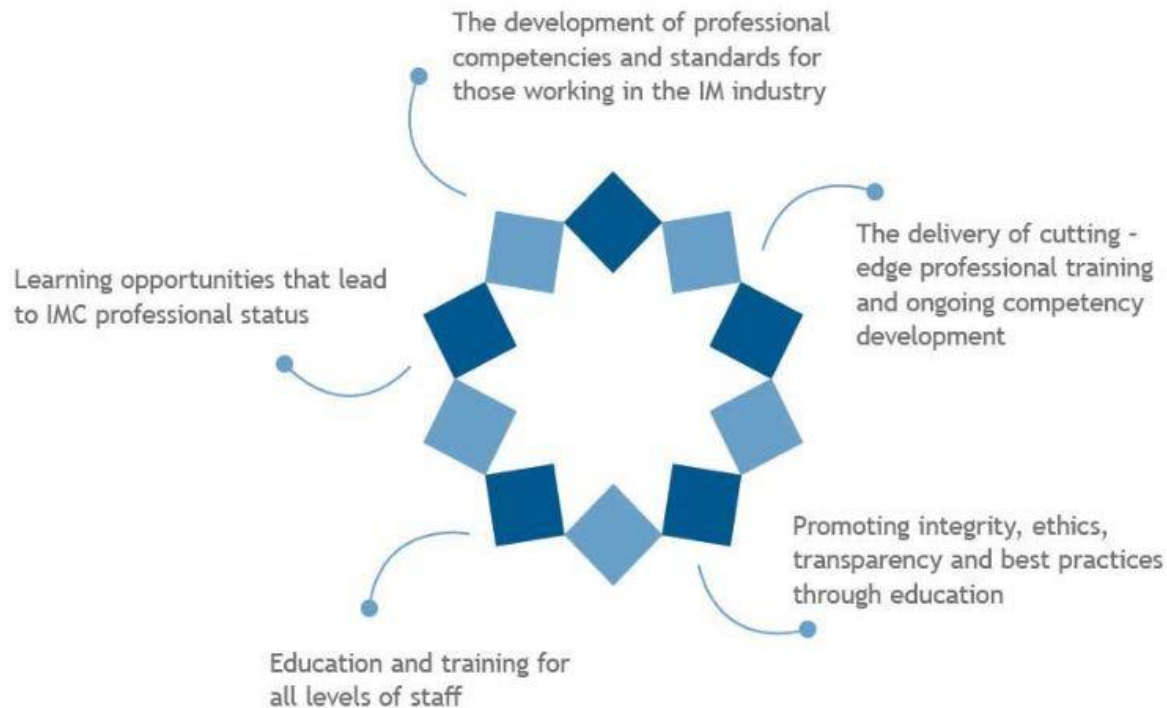

The Objectives of the IMC Education and Training Division (IMCET)





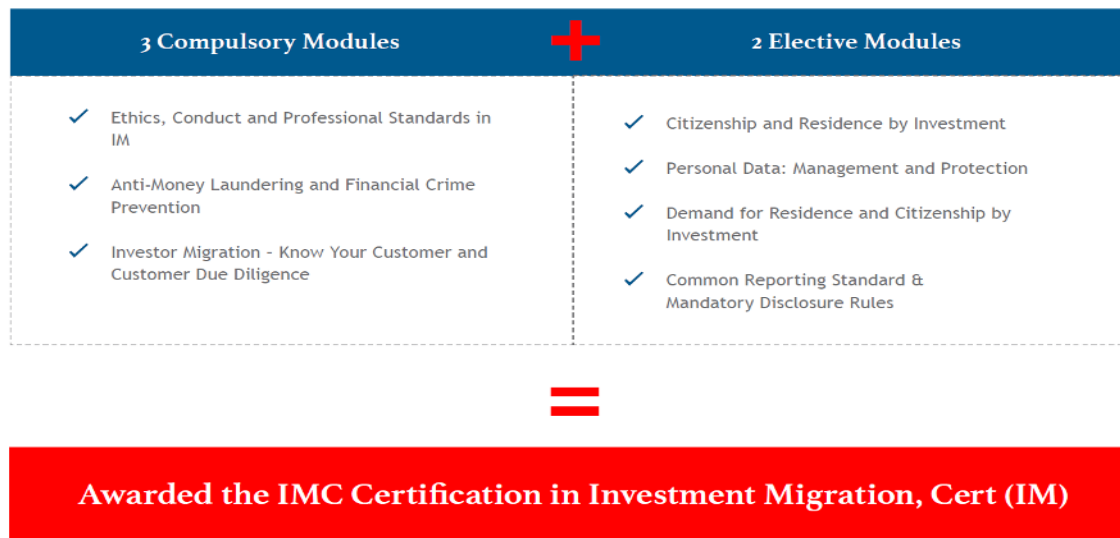
The Certification in Investment Migration

1. The ‘Certification in Investment Migration’ is the first global IM course of its type, which was specially designed for those working in the industry
2. The course is designed in a way that enables you to study at a time and in a format that works for your lifestyle
3. On successful completion, the ‘IMC Certification in Investment Migration’ certificate is awarded, together with the designation Cert (IM)



New Training Framework

IMCET's training portfolio now consists of 7 specialised modules. Students can choose to create their own learning journey through a combination of 3 compulsory and 4 elective modules which once successfully completed, will convert in the Cert (IM) designation. The Certification comes at an investment of EUR 750. However, students can now also choose to study Modules individually for EUR 180 each.
